PreK Tuition Credit Policy

Beginning with the 2018-19 school year, PreK-3 tuition shall be \$50.00 per month more than the tuition set by the Advisory Board. The \$50.00 per month is a tuition credit against kindergarten tuition. The Advisory Board may adjust the amount of the tuition credit prior to the start of the next school year.

All PreK-3 students who pay the full tuition amount, the tuition credit amount, all fees and assessments for the PreK-3 school year, shall be given the tuition credit against that student's kindergarten tuition on a monthly basis corresponding to the PreK-3 month the tuition credit was paid. If a PreK-3 student enrolls for less than a full school year and pays a pro rata tuition amount, pro rata tuition credit, pro rata amount of all fees and assessments for the student's PreK-3 school year, that student shall be given the tuition credit against kindergarten tuition on a monthly basis corresponding to the PreK-3 month the tuition credit was paid. The PreK-3 tuition credit against kindergarten tuition is student specific and not transferable to another student enrolled at St. John. PreK-3 tuition credit against kindergarten tuition is non-refundable and can only be realized monthly by the student's enrollment in kindergarten. If a student with PreK-3 tuition credit against kindergarten tuition does not enroll in kindergarten or enrolls and does not complete the kindergarten school year, the tuition credit for the kindergarten school year is forfeited or tuition credit for the remainder of the kindergarten school year is forfeited. Any lapse in enrollment by a PreK-3 student for any amount of time results in the forfeit of all accrued kindergarten tuition credit.

Beginning with the 2019-2020 school year, PreK-4 tuition shall be \$50.00 per month more than the tuition set by the Advisory Board. The \$50.00 per month is a tuition credit against 1ST grade tuition. The Advisory Board may adjust the amount of the tuition credit prior to the start of the next school year.

All PreK-4 students who pay the full tuition amount, the tuition credit amount, all fees and assessments for the PreK-4 school year, shall be given the tuition credit against that student's 1ST grade tuition on a monthly basis corresponding to the PreK-4 month the tuition credit was paid. If a PreK-4 student enrolls for less than a full school year and pays a pro rata tuition amount, pro rata tuition credit, pro rata amount of all fees and assessments for the student's PreK-4 school year, that student shall be given the tuition credit against 1ST grade tuition on a monthly basis corresponding to the PreK-4 month the tuition credit was paid. The PreK-4 tuition credit against 1ST grade tuition is student specific and not transferable to another student enrolled at St. John. PreK-4 tuition credit against 1ST grade tuition is non-refundable and can only be realized monthly by the student's enrollment in 1ST grade. If a student with PreK-4 tuition credit against 1ST grade tuition does not enroll in 1ST grade or enrolls and does not complete the 1ST grade school year, the tuition credit for the 1ST grade school year is forfeited or tuition credit for the remainder of the 1ST grade school year is forfeited. Any lapse in enrollment by a PreK-4 student for any amount of time results in the forfeit of all accrued 1ST grade tuition credit.
